RELEASE AND ACKNOWLEDGMENT OF STANDARDS

This document must be completed and signed by the participant in the Legacy Institute Leadership Training Center Project (herein "Project").

I the undersigned, (hereinafter referred to as "participant") of Legacy Institute Leadership Training Center, in consideration of the participant being allowed to participate in the Project hereby agrees as follows:

General Release: Covenant not to sue and to release, indemnify and save and hold harmless, the Legacy Institute and all their affiliated organizations and boards of trustees or directors, officers, agents and employees and counselors or helpers (herein collectively "Institute"), from and against claims or suits brought against the Institute based upon or resulting from personal or bodily injuries sustained by the participant arising out of, or in the course of, participant's participation in the Project or any of the Institute's different activities, whether the injuries are caused by the Institute's negligence or not.

This covenant and release shall not be applicable to any claims covered or fully compensable by any no-fault medical or accident insurance carried by the Institute, liability insurance carried by the Institute for its negligence, or insurance carried by the parents or the participants involved in the activity, but shall be fully applicable to that portion of a claim that is part of any deductible, is in excess of any policy limits or to the extent any such claims are not otherwise covered by an existing insurance policy held by the Institute.

Consent to Use Photographs: The undersigned participant also consents to, and authorizes the unlimited use and reproduction by the Institute, or anyone authorized by the Institute, of any and all photographs, proofs, films, or videotapes (herein collectively "photos") which may be taken of the applicant by the Institute while participating in, or traveling to or from, any project site sponsored by the Institute. Photos may be used without limitation by the Institute for any purpose whatsoever, including, use in Institute publications, for advertising, in television programs, on internet web site, in other media or in any other manner, and may be edited as the Institute deems fit. Photos shall be the sole and exclusive property of the Institute.

Standard of Conduct: Because the conduct of each participant in the Project may bare on the safety and well-being of all participants, the Institute requires participant to exhibit high standards of personal conduct based on God's law. Therefore, the Institute forbids participant's misuse of intoxicants, use or possession of any illegal drugs, sexual misconduct, stealing, smoking, disorderly conduct, intentional destruction of property, criminal activity, refusal to cooperate with Institute personnel or any conduct or attitudes not in keeping with God's law, or the Institute's purposes.

If participant does not abide by the rules and standards of the Institute, participant may be sent home at the discretion of the Institute, and at the expense of participant, which expenses, if incurred, the undersigned agrees to reimburse the Institute.
